Thank you for your request concerning Adult ADHD Assessment Pathway.

Your request has been considered and processed in accordance with the requirements of the Freedom of Information (FOI) Act 2000.

Please can you provide information on:

(1) Please provide details of your Adult ADHD Assessment pathway.

Please see attached our Shared Care Protocol for the treatment of ADHD in Hertfordshire.

(2) Please provide information on your current throughput for each stage of the pathway.

Please see attached spreadsheet.

CAVEAT: The stages identified are from contact with our Single Point of Access (SPA) and the date of initial assessment using the ICD10 code of F90.0 - Attention-deficit hyperactivity disorder diagnosis.

The Trust considers that entries of 5 or less are sufficiently small to be potentially identifiable personal data. On this basis, this information is exempt from the duty to publish (Section 40 (2) FOI Act 2000).

(3) Please provide information on the number of people waiting for each stage

(4) It is our understanding you have an ADHD screening stage. Please can you provide:

(a) Details of the screening process. In particular:

- (i) An outline of the process**
- (ii) What screening tools are routinely used.**

The Trust asks referrers of adults with suspected ADHD to complete the following information in line with NICE guidance on the diagnosis of ADHD:

WEISS Functional rating scale – conducted by a health professional
Substance Misuse Tool – self completed.
Supply evidence of demonstrating symptomology prior to age 12 – self submitted.

- (iii) What qualifications the screening staff member must have**
- (iv) Confirmation all staff members doing the screenings had the qualification in (iii). If not then please outline the number of screenings done by people**



meeting the qualification standard and the number not meeting the qualification standard.

We do not hold this information¹. These tools are completed in primary care with the person being referred.

In line with NICE Guidance referrals for ADHD diagnosis will be progressed if the functional rating scale indicates impairment, and there is evidence of symptomology in childhood. Further to this, that substance misuse is not a high risk requiring the more appropriate referral to substance misuse services as an initial step.

(b) How many people were screened in the last year

We are unable to provide this level of data on rejected screening as this is not held in a reportable format. For us to provide this level of data would involve manually scrutinising every service users record. This would invoke S12 - Cost of compliance exceeds the appropriate limit.

(5) For those that go on to be put forward for an Adult ADHD Assessment. In the past year:

(a) How many people were assessed

Again, this information is not held in a reportable manner. We are unable to give the number of assessments that resulted in a ADHD diagnosis without manually scrutinising the service users record.

Our Single Point of Access will consider if there are recommendations for signposting and provide this on a referral by referral basis.

(c) The understanding of ADHD has changed substantially in recent years. How does the trust ensure that their policy does not compound errors of the past.

The Trust refers to National Institute for Health and Care Excellent guidance, which is regularly updated, and applies this.
