Thank you for your request concerning employment tribunal claims.

Your request has been considered and processed in accordance with the requirements of the Freedom of Information (FOI) Act 2000.

I am submitting this request under the Freedom of Information Act 2000. I am requesting information from the following financial years: 2018/19; 2019/20; 2020/21; 2021/22; 2022/23; and 2023/24 to the present day.

Please disclose the following:

1. How many employment tribunal (ET1) claims have been made against the organisation since 2018/19. If possible, please break this down by type (e.g., public interest disclosure, unfair dismissal, discrimination). If this breakdown takes too long to respond to the FOI then please omit it.

We have applied Exemption Section 40(2) to releasing the type of claims. This is because once broken down to this level of detail it would be sufficiently small enough to be potentially identifiable data and constitute a breach of the Data Protection Act (2018)¹.

2. Of those ET1 claims, how many have been defended against by the organisation since 2018/19; Again, continue with a breakdown by type. If this exceeds the time limit then please omit it from the FOI request.
